## Proforma / Invoice

A commercial or pro forma invoice is needed when you ship goods outside the European Union. It is mainly a declaration including all information relating to goods, which will be used by customs authorities in order to evaluate the duties or taxes to pay.

- \* A commercial invoice is used when the goods are related to a commercial transaction or for resale.
- \* A pro forma invoice is used when sending goods without any commercial value (for example samples).

!!! 3 copies of invoice / proforma must be attached to the parcel in the sticky pocket.

VAT is required only in case sender is company

## The requirements for EORI:

B2B: need EORI for shipper & consignee B2C: need EORI for shipper C2C: no need

Language of the invoice has to be English.

Currency is the one declared by the customer. Can be any currency.

Minimal values in invoice:

For document without any commercial value, minimal value is  $0 \in$ ;

For goods, minimal value to be 1€;
